RESOLUTION COMMITTING LOCAL FUNDS

WHEREAS, the City Council of the City of Le Roy, Illinois has taken action to submit an Illinois Community Development Assistance Program (CDAP) public facilities application,

WHEREAS, receipt of CDAP grant assistance is essential to allow the City of Le Roy to undertake the project to construct a water treatment plant,

WHEREAS, criteria of CDAP are such that financial participation by the grantee is required in conjunction with CDAP funds, and

WHEREAS, the City of Le Roy has certain monies allocated for the above-referenced project with cash on hand, as needed.

NOW, THEREFORE, BE IT RESOLVED THAT the City of Le Roy does hereby commit funds for use in conjunction with an Illinois Community Development Assistance Program grant, such funds to equal 5% of the estimated total project cost of \$2,000,000, or \$100,000.
