AN ORDINANCE APPROVING EXTENSION OF WATER DISTRIBUTION SYSTEM TO LOT 17 BUCKLES GROVE SUBDIVISION IN THE SOUTHEAST QUARTER OF SECTION 29, TOWNSHIP 22 NORTH, RANGE 4 EAST OF THE THIRD PRINCIPAL MERIDIAN, McLEAN COUNTY, ILLINOIS.
