ORDINANCE NO. 490

AN ORDINANCE AMENDING CHAPTER 6 - WATER SERVICE, SECTION 6.04, MUNICIPAL CODE, LE ROY, ILLINOIS, 1975 (as amended),

WHEREAS, the City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, has determined that it is necessary, and in the best interests of the City and its residents, that certain changes be made to Chapter 6, Water Service, Section 6.04, Municipal Code, LeRoy, Illinois, 1975 (as amended), in order to provide that required materials be used.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of LeRoy, in lawful meeting assembled, as follows:

Section 1. That Section 6.04 of Chapter 6 of the Municipal Code of LeRoy, Illinois, 1975 (as amended), is hereby amended, by addition of the following words and figures at the end of the existing language of said section, as follows:

Water service pipes from the City watermain to the building or other facility for which the water service connection is made shall be constructed of either Type K copper pipe or polyethylene pipe, 3/4 inch minimum outside diameter thru 2 inch maximum outside diameter, and if constructed of polyethylene pipe, said pipe shall meet the specifications of ASTM - D2239, SDR - 7 Class 160 PSL.

Section 2. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
