ORDINANCE NO. 856

AN ORDINANCE AMENDING CHAPTER 6 WATER SERVICE, SECTION 6.23 TURNING ON WATER FROM PUBLIC HYDRANTS, OF THE MUNICIPAL CODE OF THE CITY OF LEROY, ILLINOIS, 1975 (as amended)

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined it is in the best interest of the City of LeRoy and of its residents to amend Section 6.23 of Chapter 6 Water Service, of the Municipal Code of the City of LeRoy, Illinois, 1975 (as amended),

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, Illinois in lawful meeting assembled, as follows:

<u>Section 1.</u> Section 6.23 of Chapter 6, Municipal Code of the City of LeRoy, Illinois, 1975 (as amended), is hereby repealed.

<u>Section 2.</u> New Section 6.23 of Chapter 6 Water Service, of the Municipal Code of the City of LeRoy, Illinois, 1975 (as amended) is hereby adopted as follows:

6.23 <u>Turning on water from public hydrants</u>. All fire hydrants or "fire plugs" are declared to be public hydrants; no person other than a city employee, city officer, or a member of the LeRoy Fire Protection District (when conducting official business, such as training exercises, cleaning of equipment, or responding to a fire or other emergency), or a member of any other area fire department, or other appropriate emergency response official (when responding in an emergency situation), shall open any city fire hydrant or attempt to draw any water from same.

<u>Section 3.</u> This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
