RESOLUTION OF THE CITY OF LE ROY SUPPORTING THE NATIONAL INCIDENT MANAGEMENT SYSTEM

WHEREAS, the City of Le Roy desires to maximize its capability to respond to critical incidents that threaten the well-being of its citizens, and

WHEREAS, Emergency Response to critical incidents, whether natural or otherwise, requires integrated professional management, and

WHEREAS, Unified Command of such incidents is recognized as the management model to maximize the public safety response, and

WHEREAS, the National Incident Management System, hereinafter referred to as NIMS, has been identified by the Federal Government as being the requisite Emergency Management System for all political subdivisions, and

WHEREAS, failure to adopt NIMS as the requisite Emergency Management may preclude reimbursement to the city for cost expended during and after a declared emergency or disaster and for training and preparation for such disaster of emergencies; now, therefore,

BE IT RESOLVED by the City Council that it shall be the policy of the City of Le Roy to adopt and employ the NIMS concept of emergency planning and unified command for critical incidents.
