AN ORDINANCE AMENDING TITLE 8; CHAPTER 1 OF THE MUNICIPAL CODE OF LE ROY, ILLINOIS, 2003, WATER TAPS FEES AND INSPECTION FEES

WHEREAS, the Mayor and City Council of the City of Le Roy, McLean County, Illinois, an Illinois municipal corporation, have reviewed the fees for Water Tap Feet and Inspection Fees; and

WHEREAS, the Mayor and City Council of the City of Le Roy have determined that said fees shall be increased, being in the best interest of the city and its residents; and

WHEREAS, all things required by law an ordinance to be done in regard to increasing said fees has been completed;

NOW, THEREFORE BE IT ORDAINED, by the City Council of the City of Le Roy, Illinois in lawful meeting assembled, as follows:

SECTION 1. Title 8, Water Use and Service, Chapter 1, Section 3B of the Municipal Code of Le Roy, Illinois 2003, is hereby amended:

3B # 3. Every connection will be assessed a tap fee based on the following type of

connection: Residential Tap

= \$ 500 (includes all materials)

Commercial Tap

= \$ 750 (plus the cost of all materials)

Institutional Tap

= \$ 750 (plus the cost of all materials)

Industrial Tap

= \$ 1,500 (plus the cost of all materials)

SECTION 2. Title 8, Water Use and Service, Chapter 1, Section 3F of the Municipal Code of Le Roy, Illinois 2003, is hereby amended by the addition of:

A \$50 inspection fee will be assessed for each required inspection.

SECTION 3. This ordinance shall be in full force and effect from and after its passage and approval as required by law.
