ORDINANCE NO. 17-02-02-42

AN ORDINANCE AMENDING THE CITY CODE PROVISIONS RELATING TO WATER USER FEES

- WHEREAS, the City of Le Roy is an Illinois municipal corporation operating in accordance with the Illinois Municipal Code, 65 ILCS 5/1-1-1 et seq.; and
- **WHEREAS**, the City operates a water and sewer system that is funded, in part, through water and sewer user fees; and
- **WHEREAS**, in 2016, the City issued bonds for various capital improvement projects to the City's water and sewer systems, which bonds require the imposition of an additional user fee to pay the debt service on these financial obligations; and
- **WHEREAS**, in furtherance of these projects, the City desires to amend the City Code provisions relating to water user fees as set forth in this Ordinance (a separate ordinance will impose similar sewer user fees).
- **NOW, THEREFORE, BE IT ORDAINED** by the Mayor and City Council of the City of Le Roy, McLean County, Illinois, as follows:
- **Section 1.** Recitals. The above-referenced recitals are hereby incorporated into this Ordinance by this reference.
- **Section 2.** <u>Amendment to Section 8-1-7.</u> Section 8-1-7, entitled "Water Rates," of the City of Le Roy Code of Ordinances is hereby amended to add a new Subsection E, entitled "Water Capital Bond Project Fee," as follows:
 - E. Water Capital Bond Project Fee: All utility customers of the city of LeRoy will be required to pay a five dollar (\$5.00) per month fee to finance capital projects relating to the water system, including payment of the debt service on the capital bonds issued in 2016.
- **Section 3.** <u>Conflict.</u> All Ordinances and parts of Ordinances in conflict with this Ordinance are hereby repealed.
- **Section 4.** Effective Date. This Ordinance shall be in full force and effect following its passage and approval as required by law.
