## AN ORDINANCE AMENDING CHAPTER 6, SECTIONS 6.15 and 6.17

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is in the best interests of the city and its residents that the charge be increased for turning water service on or off from the city water distribution system to a private residence or commercial location or other water user, in order to defray the expense to the city for accomplishing the same,

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

Section 1. That Chapter 6, Municipal Code of LeRoy (1975), Section 6.15 PAYMENT OF BILLS., is hereby amended by deleting the last sentence of the first paragraph and substituting therefor in words and figures as follows:

within 15 days, and the city may at once shut off the water supply until arrears have been paid, plus the amount of \$5.00 for the cost of turning the water off and an additional \$5.00 for the cost of turning the water on."

Section 2. That Chapter 6, Municipal Code of LeRoy (1975), Section 6.17 DISCONTINUING WATER SERVICE., is hereby amended by deleting the last sentence of said Section and substituting therefor in words and figures as follows:

"Such water supply may again be turned on upon such consumer filing written application therefor, and paying the City Clerk the sum of \$5.00 for the cost of turning the supply off, and an additional \$5.00 for turning the water supply on, the latter fee being due at such time as the water supply is turned on, and shall also pay all arrearages for water rent, if any."

Section 3. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
