## AN ORDINANCE AMENDING SECTION 6.14 OF CHAPTER 6, MUNICIPAL CODE OF LEROY, ILLINOIS, 1975 (as amended)

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is in the best interests of the City and of its residents to make improvements to the city water treatment and distribution system; and

WHEREAS, the Mayor and City Council of the City of LeRoy find that current user fees for distribution and use of water treated and pumped by the city to the users are not sufficient to permit the necessary improvements to the treatment and distribution systems,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

Section 1. Section 6.14 of Chapter 6 of the Municipal Code of LeRoy, Illinois, 1975 (as amended), and Section 1 of Ordinance No. 96 adopted June 4, 1979, are hereby repealed effective August 15, 1997.

- Section 2. New Section 6.14 of Chapter 6 of the Municipal Code of LeRoy, Illinois, 1975 (as amended), is hereby adopted in words and in figures as follows:
  - 6.14 WATER METER RATES. The water rates for all single residences and single business meters shall be as follows:
    - \$3.00 minimum for first 650 gallons used; and
    - \$3.00 for each 1,000 gallons beyond the minimum quantity.

The water rates for single meters serving more than one single family unit or more than one business, or combination thereof, shall be:

\$3.00 multiplied by the individual family units or businesses served from the one meter to determine the minimum charge; and

\$3.00 for each 1,000 gallons beyond the minimum quantity used (as measured thru the meter, regardless of the number of individual family units or businesses served from the one meter).

Fifty percent will be added to the above rates to metered customers outside the corporate limits of the City of LeRoy.

<u>Section 3</u>. All ordinances, or parts thereof, and all resolutions, or parts thereof, in conflict with this ordinance shall be and the same are hereby repealed to the extent of such conflict, and this ordinance shall be in full force and effect as set forth hereafter.

Section 4. Nothing in this ordinance hereby adopted shall be construed to affect any suit or proceeding pending in any court, or any rights acquired, or any liability incurred, or any cause or causes of action acquired or existing, under any act or ordinance hereby repealed as cited in Section 3 of this ordinance; nor shall any just or legal right or remedy of any character be lost, impaired or affected by this ordinance.

Section 5. This Ordinance shall be in full force and effect from and after its passage, approval, and publication as required by law.
