### ORDINANCE NO. <u>01-10-02-52</u>

## AN ORDINANCE APPROVING A TEXT AMENDMENT TO THE MUNICIPAL CODE, LE ROY, ILLINOIS, 2003 TITLE 10, ZONING

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, deem it to be in the best interests of the city and its residents that the zoning ordinance amendments hereinafter set forth be approved, and

WHEREAS, a public hearing was held by the Zoning Board of Appeals of the City of Le Roy, Illinois, on October 7, 2004 at 7:00 P.M. at the City Hall, Le Roy, Illinois, in accordance with the laws of the State of Illinois and the Ordinance of the City of Le Roy, McLean County, Illinois, to consider said petition, after due notice was given in accordance with all applicable laws and ordinances, and

WHEREAS, said Zoning Board of Appeals did hold a hearing as required by the laws of the State of Illinois and the Ordinance of the City of Le Roy, McLean County, Illinois and did recommend that said petition for text amendment be passed, and

WHEREAS, all things required by law and ordinance to be done in regard to the amendment of the hereinafter described text have been completed,

**NOW, THEREFORE BE IT ORDAINED,** by the City Council of the City of Le Roy, Illinois in lawful meeting assembled, as follows:

**SECTION 1.** Title 10, Chapter 2, Section 4 (Header) ADDITIONAL PERMITTED USES shall be replaced by SPECIAL PERMITTED USES.

Title 10, Chapter 2, Section 4 (A) Additional permitted uses shall be replaced by special permitted uses.

Title 10, Chapter 2, Section 4 (B) Additional permitted use shall be replaced by special permitted use at each occurrence.

Title 10, Chapter 2, Section 4 (C) Additional permitted use shall be replaced by special permitted use.

Title 10, Chapter 2, Section 4 (D) Additional permitted use shall be replaced by special permitted use at each occurrence.

**SECTION 2.** Title 10, Chapter 2, Section 5, Sub-section C. Fees: The application fee of \$75.00 for a variation shall be changed to a fee of \$100.00.

**SECTION 3.** This ordinance shall be in full force and effect from and after its passage and approval as required by law
