AN ORDINANCE AMENDING SECTION 5 OF CHAPTER 1 OF TITLE 9, BUILDING CODE, OF THE MUNICIPAL CODE, LE ROY, ILLINOIS, 2003

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, deem it to be in the best interests of the city and its residents that the amendments to the building code hereinafter set forth be approved, and

WHEREAS, all things required by law and ordinance to be done in regard to the amendment of the hereinafter described text have been completed,

NOW, THEREFORE BE IT ORDAINED, by the City Council of the City of Le Roy, Illinois in lawful meeting assembled, as follows:

SECTION 1. The number "2003" wherever it appears in the body of Title 9, Chapter 1, Section 5, Electrical Code, Municipal Code of the City of LeRoy, Illinois, 2003, is hereby deleted and the number "2005" is hereby substituted for the same in amendment of said section. It is the intention of the City Council of the City of LeRoy that after the date set forth hereafter as the effective date of this ordinance, Sept. 6, 2005, the National Electrical Code 2003 will no longer be in use or accepted by the City, except for permits that have already been approved under the now current building code and for determination of violations for work done under said permits.

SECTION 2. This ordinance shall be in full force and effect from and after its passage and approval as required by law.
