ORDINANCE NO. 07-04-02-51

AN ORDINANCE APPROVING TEXT AMENDMENTS TO THE MUNICIPAL CODE, LE ROY, ILLINOIS, 2003 TITLE 10, ZONING

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, deem it to be in the best interests of the city and its residents that the zoning ordinance amendments hereinafter set forth be approved, and.

WHEREAS, a public hearing was held by the Zoning Board of Appeals of the City of Le Roy, Illinois, on April 5th, 2007. at City Hall, Le Roy, Illinois, in accordance with the laws of the State of Illinois and the Ordinance of the City of Le Roy, McLean County, Illinois, to consider said amendments, after due notice was given in accordance with all applicable laws and ordinances, and,

WHEREAS, said Zoning Board of Appeals did hold a hearing as required by the laws of the State of Illinois and the Ordinance of the City of Le Roy, McLean County, Illinois and did recommend said amendments to be passed, and,

NOW, THEREFORE BE IT ORDAINED, by the City Council of the City of Le Roy, Illinois in lawful meeting assembled, as follows:

SECTION 1.

Title 10, Chapter 1, Section 3 Definition of Accessory Use or Structure: Amend language "one thousand(1000) square feet" with "seven hundred and fifty(750) square feet."

Title 10, Chapter 1, Section 3 Definition of <u>Lot Line</u>, <u>Front</u>: Amend and delete language "The owner of a corner lot may select either street lot line as the front lot line."

Title 10, Chapter 2, Section 4 (B) Amended by the inclusion of the following, after the words (15) days prior to the hearing. "A notification sign will be posted on the property as to the time, date, place, and request of such public hearing."

Title 10, Chapter 2 Section 4 (D) Amend and delete language "by the zoning board of appeals",

Title 10, Chapter 2, Section 5 (A) Amend and delete the language: "In the exercise of such authority, the City Council shall delegate to the zoning board of appeals the power to decide, after public hearing, such variations specifically set forth in subsection D of this section."

Title 10, Chapter 2, Section 5 (A) Amend and delete language: "or to create a conditional permitted use other than is allowed in accordance with the provisions of subsection D of this section."

Title 10, Chapter 2, Section 5 (B) City Clerk shall be amended and replaced by "Code Compliance Officer."

Title 10, Chapter 2, Section 5 (B) Amended by the inclusion of the following after the words published in McLean County. "A notification sign will be posted on the property as to the time, date, place, and request of such public hearing."

Title 10, Chapter 2, Section 5 (D 1) Amend and delete such language,

Title 10, Chapter 2, Section 5 (D 2) Amend and delete such language,

Title 10, Chapter 2, Section 5 (D 3) Amend and delete such language,

Title 10, Chapter 2, Section 5 (D 4) Amend and delete such language,

Title 10, Chapter 2, Section 5 (E 1) Amend and delete language: "and, when applicable, to decide a variation."

Title 10, Chapter 2, Section 5 (E 2) Amend and delete language: "other than a variation upon which the zoning board of appeals is required to decide,"

Title 10, Chapter 2, Section 5 (E 3) Amend and delete such language,

Title 10, Chapter 2, Section 5 (E 4) Amend and delete language, "or, when applicable, the Zoning Board of Appeals,",

SECTION 2. This ordinance shall be in full force and effect from and after its passage and approval as required by law.
