ORDINANCE NO. 12-03-01-51

AN ORDINANCE ADOPTING A TEXT AMENDMENT TO THE MUNICIPAL CODE OF THE CITY OF LE ROY, MC LEAN COUNTY, ILLINOIS, 2003 TITLE 10, BUILDING REGULATIONS

WHEREAS, the Mayor and City Council of the City of Le Roy, McLean County, Illinois, an Illinois municipal corporation, deem it to be in the best interest of the City and its residents that the zoning ordinance amendment hereinafter set forth be approved; and

NOW, THEREFORE BE IT ORDAINED, by the City Council of the City of Le Roy, Illinois in lawful meeting assembled, as follows:

SECTION 1. Title 10, Chapter 1, is hereby adopted as follows:

10-1-3:

ACCESSORY USE OR STRUCTURE: A use or structure on the same lot with, and of a nature customarily incidental and subordinate to, the principle use or structure. An "accessory structure" shall not have floor space greater than nine hundred fifty (950) square feet.

10-6A-4:

A. - 2. Accessory Structures:

a. No accessory structure shall exceed one story or a maximum height of fifteen feet (15') as a vertical distance from finished floor to: The highest point of a flat roof; The deck line of a mansard roof; The average height between top wall plate and ridge of gable, hip and gambrel roof's.

10-6B-4: Accessory Structures:

a. No accessory structure shall exceed one story or a maximum height of fifteen feet (15') as a vertical distance from finished floor to: The highest point of a flat roof; The deck line of a mansard roof; The average height between top wall plate and ridge of gable, hip, and gambrel roof's.

SECTION 2. This ordinance shall be in full force and effect from and after its passage and approval as required by law.
