AN ORDINANCE AMENDING THE MUNICIPAL CODE, LEROY, ILLINOIS, 1975, CHAPTER 21, ZONING, SECTIONS 21.12, 21.13, 21.14 and 21.15.

Whereas, the City Council of the City of LeRoy has determined that there are a number of residences and dwelling structures that were in existence on February 18, 1975, which are presently still in average, good or better condition, and which structures are located within the central commercial, highway-oriented commercial, light industrial or heavy industrial zoning districts under the Zoning Code for the City of LeRoy, and

Whereas, the City Council for the City of LeRoy has determined that these dwelling structures from time to time may be appropriately enlarged, extended or altered, to enhance their value or usability to the owners and occupants, and

Whereas, as a result of the non-conforming use of said dwelling structures in the central commercial, highway-oriented commercial, light industrial and heavy industrial zoning districts within said city, the owners of said structures are required to obtain variances, map amendments, text amendments or other permits or changes to the zoning map or zoning code from time to time in order to comply with the Zoning Code when enlarging, extending or altering said structures, and that said requirements from time to time are not economical either for the owner or for the city or citizens of said city,

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of LeRoy, Illinois, as follows:

Section 1. That Chapter 21, Section 21.12, C-1, CENTRAL COMMERCIAL DISTRICT, Section 21.13, C-2, HIGHWAY-ORIENTED COMMERCIAL DISTRICT, Section 21.14, I-1, LIGHT INDUSTRIAL DISTRICT, and Section 21.15, I-2, HEAVY INDUSTRIAL DISTRICT, all be amended by adding thereto new sections as follows: New Section 21.12(G), New Section 21.13(G), New Section 21.14(H) and New Section 21.15(H), all to read as follows:

Dwelling structures and structures accessory thereto in existence on February 18, 1975, may be enlarged, extended or altered even though such enlargement, extension or alteration is not done pursuant to making the structure or its use conform with the requirements of the zoning district in which the non-conforming dwelling structure is located. Such enlargement, extension or alteration shall be made in accordance with the applicable provisions for yards, set back requirements, height regulations, lot area, frontage, sign regulations and off-street parking requirements as are set forth in Section 21.09 R-1, One-and-Two Family Residential District, of this Chapter. In all other respects, dwelling structures in this district shall be deemed non-conforming uses and shall be subject to all provisions of this Ordinance regarding nonconforming uses and structures. The nature of this zoning district and the uses allowed by both permit and additional use preclude the provision of services, amenities and protection $% \left(1\right) =\left(1\right) \left(1\right) \left($ from other land uses which are afforded to residential uses by the regulations of the Residence Districts, and it is not intended that the regulations of this zoning district afford such services, amenities and protection to residential uses located therein.

Section 2. This ordinance shall be in full force and effect after its passage, approval, and publication in pamphlet form as required by city ordinance and state law.
