AN ORDINANCE PROVIDING FOR PUBLICATION OF CITY ORDINANCES IN PAMPHLET FORM AMENDING THE MUNICIPAL CODE, LEROY, ILLINOIS, 1975, CHAPTER 1, GENERAL, BY ADDITION OF NEW SECTION 1.11, PUBLICATION OF ORDINANCES.

Whereas, the Mayor and City Council of the City of LeRoy, Illinois, have determined that municipal funds may be conserved and expenses reduced by the publication of all ordinances in pamphlet form; and

Whereas, the laws of the State of Illinois provide that municipal ordinances may be printed or published in book or pamphlet form, published by authority of the corporate authorities of the municipality (Chapter 24, Section 1-2-4 of the Illinois Revised Statutes, 1979 (as amended),

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of LeRoy in lawful meeting assembled:

Section 1. That all ordinances, as permitted under the statutes of the State of Illinois, specifically Chapter 24,1-2-4; Illinois Revised Statutes 1979 (as amended), as of January 19, 1981, adopted by the City of LeRoy shall be published in pamphlet form unless such publication is prohibited or required to be otherwise by applicable state law.

Section 2. That the City Clerk is hereby directed to publish all ordinances in the future in pamphlet form unless otherwise directed from time to time by the Mayor and City Council of the City of LeRoy or unless otherwise required by the laws of the State of Illinois.

Section 3. That during the regular meeting of the Mayor and City Council on Monday, January 19, 1981, action approving the publication of all future ordinances in pamphlet form was taken and adopted at said meeting and that this ordinance shall confirm such action taken at said meeting.

Section 4. That this ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as directed hereby by the corporate authorities and as required by law.
