AN ORDINANCE ZONING LAND NEWLY ANNEXED TO THE CITY OF LEROY, MCLEAN COUNTY, ILLINOIS, SAID LAND BEING COMMONLY KNOWN AS "LEROY AUTO/TRUCK PLAZA".

Whereas, the land described below has been newly annexed to the City of LeRoy and was the subject matter of an Annexation Agreement entered into between the City and the Owner thereof; and,

Whereas, the said Annexation Agreement provided that the City would zone this land in accordance with that agreement, specifically C-2, Highway Commercial; and,

Whereas, prior to the annexation of the land and the execution of the Annexation Agreement all hearings required to be held took place pursuant to State Statutes.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of LeRoy, McLean County, Illinois, as follows:

Section 1. That the land legally described as follows:

That part of the North 35 acres of the Northeast Quarter of the Northeast Quarter of Section 29, Township 22 North, Range 4 East of the Third Principal Meridian lying South and West of the right of way of F.A.I. Route 7 as conveyed to the State of Illinois by instrument recorded September 18,1969 as Document No. 69-6697 and being more particularly described as follows: Beginning at the Northeast corner/8f Buckles Grove Bicentennial Addition in the City of LeRoy, McLean County, IL; thence South 89 degrees-41'-18" West 445.74 ft. on the North line of the said Lot 1-A and the Westerly extension thereof to a point on the West line of the Northeast Quarter of the Northeast Quarter of the Said Section 29; thence North O degrees-00'-00" East 908.98 ft. on the Said West line to the Southwesterly right of way line of F.A.I. Route 74; thence South 56 degrees-39'-50" East 155.53 ft. on Said right of way line; thence South 35 degrees-25'-21" East 233.13 ft. on Said right of way line; thence South 14 degrees-34'-17" East 595.97 ft. on Said right of way line; thence South 29 degrees-03'-53" East 63.28 ft. on Said right of way line to the Point of Beginning containing 6.65 acres more or less all being situated in McLean County, Illinois, with bearings shown for descriptive purposes only,

shall be zoned C-2, Highway Commercial.

Section 2. That the City Clerk is authorized and directed to show this zoning map amendment made by this ordinance upon the official zoning map of the City.

Section 3. That this ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
