## ORDINANCE NO. 295

AN ORDINANCE AMENDING CHAPTER 21, ZONING, SECTIONS 21.04(b) AND 21.12(b) MUNICIPAL CODE OF LE ROY, ILLINOIS 1975 (AS AMENDED).

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, wish to clarify certain permitted uses within the C-1, Central Commercial District, and C-2, Highway-Oriented Commercial District, as said districts are defined under the Zoning Ordinance of the City of LeRoy,

NOW, THEREFORE, BE IT ORDAINED by the Mayor and the City Council of the City of LeRoy, Illinois, in lawful meeting assembled as follows:

Section 1. That Section 21.04(b), <u>Definitions</u>, of the Municipal Code of LeRoy, Illinois 1975 (as amended), is hereby further amended by addition of the definition of the word "warehouse" to be incorporated into the aforesaid list of definitions as item No. 78.5. <u>Warehouse</u>. Said definition to be in words as follows:

"Warehouse. A building or structure, at least partially enclosed, where wares or goods, or other similar items, are stored, whether for resale or not."

Section 2. That Section 21.12(b), <u>Permitted Uses</u>, be amended by incorporation of an explanatory Note to be included at the end of the list of Permitted Uses (currently 29 items) as follows:

"(Note - permitted uses in this district as well as in the C-2, Highway-Oriented District, to the extent that this list of permitted uses is included, all or any portion hereof, in the list of permitted uses of said District, shall not be deemed to include storage or warehouse uses other than in connection with another otherwise permitted use of the property within the District, said permitted use being required to exist on the same premises, i.e., for example a retail or wholesale business on the premises, at least a portion of which premises are devoted to a display and sales area while the rest may essentially involve storage or warehousing of the goods available for sale or distribution.)"

Section 3. That this ordinance shall be in full force and effect from and after its passage and approval in pamphlet form as required by law.
