# AN ORDINANCE AMENDING CHAPTER 21, SECTION 21.17-CORRECTING NUMBERING OF ORDINANCE SECTIONS AND SUB-SECTIONS, MUNICIPAL CODE OF LEROY, ILLINOIS, 1975 (AS AMENDED)

WHEREAS, ORDINANCE No. 452 AMENDING CHAPTER 21-ZONING-SECTION 21.17, MUNICIPAL CODE OF LEROY, 1975 (AS AMENDED), was passed and approved on August 3, 1992, by the Mayor and City Council of the City of LeRoy; and

WHEREAS, said ordinance was intended to amend provisions of Chapter 21, Zoning, the sub-section regarding "ADMINISTRATION AND ENFORCEMENT," which section was formerly numbered 21.17, but was renumbered 21.18 by Ordinance No. 268 on March 3, 1986; and

WHEREAS, Ordinance No. 452 was passed and approved inadvertently making references to Section 21.17 and subsections thereof, rather than Section 21.18 and the pertinent subsections thereof,

**NOW. THEREFORE. BE IT ORDAINED**, by the City Council of the City of LeRoy, in lawful meeting assembled, as follows:

Section 1. Section 1 of Ordinance No. 452 is hereby amended by replacing the numbers "21.17" where the same are found therein with the number "21.18." In all other respects the aforesaid Section 1 shall continue in full force and effect.

Section 2. Section 2 of Ordinance No. 452 is hereby amended by replacing the numbers "21.17" where the same are found therein with the number "21.18." In all other respects the aforesaid Section 2 shall continue in full force and effect.

Section 3. Section 3 of Ordinance No. 452 is hereby amended by replacing the numbers "21.17" where the same are found therein with the number "21.18." In all other respects the aforesaid Section 3 shall continue in full force and effect.

Section 4. Section 4 of Ordinance No. 452 is hereby amended by replacing the numbers "21.17" where the same are found therein with the number "21.18." In all other respects the aforesaid Section 4 shall continue in full force and effect.

<u>Section 5.</u> This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
