AN ORDINANCE FOR GENERAL ELECTIONS TO BE HELD IN THE CITY OF LE ROY, ILLINOIS.

BE IT ORDAINED by the Mayor and City Council of the City of Le Roy, Illinois;

That there shall be a general election in the City of Le Roy on the 7th day of April, 1981.

That at such election there shall be elected for the city, for a full term as provided by law, the following officers:

One alderman in each of the wards of the city, namely Wards Number One to Three inclusive. One Mayor

One City Clerk One Treasurer

That the ballot for such election shall be in the form prescribed by statute and the said election shall be conducted in compliance with the general election laws.

That polling places shall be open from 6 a.m. until 7 p.m. The precincts or voting districts, and the polling places, for such election shall be those prescribed by the Municipal Code of Le Roy, Illinois, 1975 as amended, establishing wards and polling places for all general elections in the city.

That the City Clerk shall certify list of candidates to County Clerk, the County Clerk shall prepare the necessary ballots, tally sheets, poll books and all necessary supplies for the conduct of such election, and all supplies and materials necessary for the courting of the ballots, making of returns and preservation of the ballots as required by the general election law.

That this ordinance shall be in full force and effect after its passage and approval as required by law.
