ORDINANCE NO.	583

AN ORDINANCE AMENDING CHAPTER 21-ZONING, SECTIONS 20.03 (h), 21.13 (e) and 21.18 (e), MUNICIPAL CODE OF LEROY, ILLINOIS, 1975 (AS AMENDED)

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is in the best interests of the City and its residents that the current zoning ordinance, Chapter 21 of the Municipal Code of LeRoy, Illinois, 1975 (as amended), be further amended,

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

- Section 1. Chapter 21 ZONING, Municipal Code of LeRoy, Illinois, 1975 (as amended), Section 20.03 (h) PERMITTED OBSTRUCTIONS IN REQUIRED YARDS, is hereby amended by addition of subsection 5., in words and figures as follows:
 - 5. Fences may be located in those portions of rear and side yards as shown in Exhibit A-1 attached hereto and incorporated herein by reference. Before a fence shall be considered a conforming structure in the zoning district in which it is constructed (for all construction taking place after the effective date of this ordinance) building and occupancy permits shall be required to be obtained and the appropriate fee paid for each.
- Section 2. Chapter 21 ZONING, Municipal Code of LeRoy, Illinois, 1975 (as amended), Section 21.13 (e) LOT AREA, FRONTAGE AND YARD REQUIREMENTS, subsection 3. Yards, is hereby amended by addition of the following language at the end of the language currently contained in subsection 3. Yards, in words and figures as follows:
 - (e) 3. Any lot located on a corner shall be deemed to have front yards on both sides of the lot adjacent to the street. Both front yards shall be required to meet the front yard requirements set forth previously in this subsection (60 feet from center of right-of-way or 25 feet, whichever is greater).
- Section 3. Chapter 21 ZONING, Municipal Code of LeRoy, Illinois, 1975 (as amended), Section 21.18 (e) OCCUPANCY CERTIFICATE, is hereby amended by repealing the last sentence thereof and substituting the following language therefor:


A fee of \$10.00 shall be charged for each occupancy permit.
