ORDINANCE NO. 626

AN ORDINANCE AMENDING CHAPTER 21, SUB-SECTION 21.17 - CORRECTING NUMBERING OF ORDINANCE SECTIONS AND SUB-SECTIONS, MUNICIPAL CODE OF LEROY, ILLINOIS, 1975 (as amended)

WHEREAS, Ordinance No. 621, AN ORDINANCE AMENDING SUB-SECTION 21.17 (G) 4. A. DECISIONS, OF CHAPTER 21, OF THE MUNICIPAL CODE OF LEROY, ILLINOIS 1975 (as amended), was passed and approved on August 7, 1995, by the Mayor and City Council of the City of LeRoy, and

WHEREAS, said ordinance was intended to amend provisions of Chapter 21, ZONING, the sub-section regarding the "ADMINISTRATION AND ENFORCEMENT" which section was formerly number 21.17, but was renumbered 21.18 by Ordinance No. 268 on March 3, 1986; and

WHEREAS, Ordinance No. 621 was passed and approved inadvertently making references to Section 21.17 and sub-sections thereof, rather than Section 21.18 and the pertinent sections thereof,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, in lawful meeting assembled, as follows:

- Section 1 of Ordinance No. 621 is hereby amended by replacing the number "21.17" where the same are found therein with the number "21.18." In all other respects the aforesaid Section 1 shall continue in full force and effect.
- Section 2 of Ordinance No. 452 is hereby amended by replacing the numbers "21.17" where the same are found therein with the number "21.18." In all other respects the aforesaid Section 2 shall continue in full force and effect.
- <u>Section 3</u>. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as required by law.
