## ORDINANCE NO. \_\_667

## AN ORDINANCE AMENDING CHAPTER 21 ZONING, OF THE MUNICIPAL CODE OF THE CITY OF LEROY, ILLINOIS 1975 (AS AMENDED)

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is in the best interests of the City and its residents that certain amendments be made to the zoning code of the City of LeRoy, and

WHEREAS, one or more hearings have been held by the Zoning Board of Appeals of the City of LeRoy to consider the proposed text amendments as set forth hereinafter, due notice having been given for any and all said hearings,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

Section 1. Chapter 21 Zoning, Municipal Code of the City of LeRoy, Illinois 1975 (as amended), Section 21.03 (f) 2., is hereby amended by addition of the following words and figures to be set forth at the end of the first sentence of said sub-section, said sentence ending "...thirty (30) percent of a rear yard.":

The total of all ground space occupied by all accessory buildings and structures in a rear yard shall not exceed thirty (30) percent of said rear yard.

Section 2. Chapter 21 Zoning, Municipal Code of the City of LeRoy, Illinois 1975 (as amended), Section 21.03 (i) 3.(B) Permit Required., is hereby amended by addition of the following words and figures to be added at the end of the existing provision:

All dishes less than two (2) feet in diameter shall be exempt from the application of any or all provisions of this sub-sub-section 3, including the requirement to obtain a building permit.

Section 3. Chapter 21 Zoning, Municipal Code of the City of LeRoy, Illinois 1975 (as amended), Section 21.04 (b) 1. Accessory Use or Structure., is hereby amended by adding the following words and figures at the end of the current provision:

An accessory structure shall not have floor space greater than 1,000 square feet.

Section 4. Chapter 21 Zoning, Municipal Code of the City of LeRoy, Illinois 1975 (as amended), Section 21.04 (b) 74. Structure., is hereby amended by addition of the following words and figures in parenthesis after the word "fences" and before the comma appearing after the word "fences":

(portable-type fencing capable of enclosing an area of up to 100 square feet shall not be considered a "fence" or "structure")

Section 5. Chapter 21 Zoning, Municipal Code of the City of LeRoy, Illinois 1975 (as amended), Section 21.18 (d) <u>Building Permit.</u>, is hereby amended by deleting the last three sentences of said section, the first of the three sentences beginning "All applications for building permits...", and the last sentence ending "...completed within one year after the issuance of a building permit.", and by addition of the following words and figures in place of the deleted provisions:

Substantial construction or erection of any building or structure must be completed within one year after the issuance of the building permit. All applications for building permits and fees charged for issuance of the same, and the issuance and regulation of such permits, shall be regulated by the applicable provisions of the city building code (as amended from time to time), as set forth in Chapter 22 of the Municipal Code of the City of LeRoy, Illinois 1975 (as amended).

Section 6. Chapter 21 Zoning, Municipal Code of the City of LeRoy, Illinois 1975 (as amended), Section 21.18 (e) Occupancy Certificate., is hereby amended by deletion of the last two sentences of said provision, the first such sentence beginning "A record of all certificates...", and the second of the two sentences ending with the words "...issuance of the certificate of occupancy.", and by addition of the following words and figures in place of the deleted provisions:

All applications for occupancy permits and any fee charged for issuance of the same, and the issuance and regulation of such permits, shall be regulated by the applicable provisions of the city building code (as amended from time to time), as set forth in Chapter 22 of the Municipal Code of the City of LeRoy, Illinois 1975 (as amended).

Section 7. Chapter 21 Zoning, Municipal Code of the City of LeRoy, Illinois 1975 (as amended), Section 21.18 (g) 3. Procedure., is hereby amended by substitution of the dollar amount "\$\_\_\_\_\_" in place of the dollar amount "\$30.00", as presently provided in the last sentence of said sub-section.

Section 8. All ordinances, or parts thereof, and all resolutions, or parts thereof, in conflict with this ordinance shall be and the same are hereby repealed to the extent of such conflict, and this ordinance shall be in full force and effect as set forth hereafter.

<u>Section 9</u>. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as required by law.
