BE IT ORDAINED by the Mayor and City Council of the City of LeRoy, McLean County, Illinois, that whereas:

By warranty deed dated August 3, 1971, recorded Murch 16, 1973, as Document #73 2493 of the deed records of McLean County, Illinois, Charles L. Gilmore and Leota Gilmore conveyed to the City of LeRoy, a municipal corporation, the following described real estate to wit:
