ORDINANCE NO. 254

AN ORDINANCE AMENDING CHAPTER 3, SECTION 3.08, CITY ADMINISTRATION, MUNICIPAL CODE OF LEROY, ILLINOIS 1975 (AS AMENDED).

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, did on July 2, 1984, adopt Ordinance No. 203 establishing Section 3.08, of Chapter 3, City Administration, Municipal Code of LeRoy, Illinois 1975 (as amended), regarding establishment of an Emergency Services Disaster Agency under the City government; and

WHEREAS, the Mayor and City Council of the City of LeRoy, Illinois, now see fit to amend said ordinance to provide further for the services to be performed by such Emergency Services Disaster Agency, and for compensation of persons serving under said agency,

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

Section 1. That Section 3.08(d)(7), EMERGENCY SERVICES DISASTER AGENCY OF THE CITY OF LEROY, ILLINOIS, is hereby amended as follows:

(7). All or any members of the Emergency Services Disaster Agency organization of the City of LeRoy may be designated as members of a Mobile Support Team created by the Director of Emergency Services Disaster Agency for the State of Illinois as may be provided from time to time by law. The leader of the Mobile Support Team shall be designated by the coordinator of the City Emergency Services Disaster Agency.

Section 2. That Section 3.08(d)(8), EMERGENCY SERVICES DISASTER AGENCY OF THE CITY OF LEROY, ILLINOIS, is hereby amended as follows:

(8). Members of the City Emergency Services Disaster Agency who are paid employees or officers of the City, if called for training by the director of Emergency Services Disaster Agency for the State of Illinois, shall receive for the time spent in such training the same rate of pay as is attached to the position held under the City Emergency Services Disaster Agency. Members who are not employees or officers of the City shall receive for such training time such compensation as may be established from time to time by the City Council of the City. Any member of a Mobile Support Team who is a City employee or officer while serving on call to duty by the governor of the State of Illinois, or the director of the Emergency Services Disaster Agency for the State of Illinois shall receive compensation and have the powers, duties, rights and immunities incident to such employment or office. Any such member who is not a paid officer or employee of the City, while so serving, shall receive from the State of Illinois such compensation as may be provided by law. The City may receive from the State Treasurer and allocate to the appropriate fund any reimbursement by the State of Illinois to the City for expenses incident to training members of the Emergency Services Disaster Agency as may be prescribed by the Director of the Emergency Services Disaster Agency for the

State of Illinois, compensation for services and expenses of members of the Mobile Support Team while serving outside the City, and any other reimbursement made by the State of Illinois incident to Emergency Services Disaster Agency activities as may be provided by law.

Section 3. That this ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as required by law.
