WHEREAS, a written petition, signed by the owners of record and the owners of the beneficial title of all land within the territory hereinafter described, has been filed with the City Clerk of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, requesting that said territory be disconnected from the City of LeRoy; and

WHEREAS, all petitions, documents and other necessary legal requirements are in full compliance with Chapter 24, Paragraph 7-3-4, Illinois Revised Statutes 1983 (as amended); and

WHEREAS, it is in the best interests of the City of LeRoy and of the citizens of said City $\,$ that said territory be disconnected from the City of LeRoy,

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of LeRoy, McLean County, Illinois, in lawful meeting assembled, as follows:

<u>Section 1</u>. That the following-described territory:

That part of the North 35 acres of the North East 1/4 of the North East 1/4 of Section 29, Township 22 North, Range 4 East of the Third Principal Meridian, lying West and South of that part of said tract conveyed to the State of Illinois for the use of Public Works and Buildings by Instrument recorded September 18, 1969, as Document No. 69-6697, in McLean County, Illinois,

is hereby disconnected from the City of LeRoy, McLean County, Illinois.

Section 2. That the City Clerk is hereby directed to record within 90 days of the adoption of this Ordinance, with the Recorder of Deeds of McLean County, Illinois, and the County Clerk of McLean County, Illinois, certified copies of this Ordinance.
