AN ORDINANCE AMENDING AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE CITY OF LEROY, MCLEAN COUNTY, ILLINOIS (TERRITORY HAVING BEEN ANNEXED OWNED BY JUDSON CHUBBUCK III AND EVELYN CHUBBUCK).

Whereas, the City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, did adopt Ordinance No. 227 on December 10, 1984, providing for the annexation of real estate described therein; and

Whereas, attached to said ordinance was a plat bearing an abbreviated legal description from that set forth in the body of the ordinance; and

Whereas, it has come to the attention of the City Council that said abbreviated legal description attached to the annexation plat had a typographical error contained therein; and

Whereas, the City Council of the City of LeRoy, McLean County, Illinois, deems it appropriate in order that there be no confusion as to the legal description of the real estate properly annexed and shown on the plat and in the legal description contained in the body of the ordinance, that said typographical error be corrected and a copy of this ordinance be recorded,

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled as follows:

Section 1. That the legal description noted on the annexation plat attached to Ordinance No. 227 previously adopted by the City Council of the City of LeRoy, Illinois, be amended in words and figures as follows:

Beginning in the fourth line of said legal description, also being the first line of the second paragraph of said legal description, and beginning after the words "The Northeast Quarter of the Northwest Quarter (except the east 500 ft.", and before the words "thereof) of Section 32", the words and figures "of the North 550 ft." should have been included, and said legal description is hereby amended to include the previously described words and figures ("of the North 550 ft.") in that part of the legal description set forth in the annexation plat as aforesaid.

Section 2. That the City Clerk is hereby directed to record with the Recorder of Deeds of McLean County, Illinois, and to file with the County Clerk of McLean County, Illinois, a certified copy of this ordinance and give notice as required by law of this annexation.

Section 3. That this ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
