AN ORDINANCE PROVIDING FOR THE CLOSING TO VEHICULAR TRAFFIC OF THE PUBLIC ALLEY LOCATED IN BLOCK 70, CONKLING'S ADDITION TO THE CITY OF LeROY, McLEAN COUNTY, ILLINOIS.

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is in the best interests of the public's safety and welfare that the public alley running East and West located in Block 70 of Conkling's Addition to the City of LeRoy, McLean County, Illinois, be closed to vehicular traffic, and

WHEREAS, the City of LeRoy has the authority to regulate vehicular traffic within its municipal limits, and

WHEREAS, the City of LeRoy has never improved said alley nor opened it for use to the public, and

WHEREAS, complaints have been made to the City of attempts by the public to make use of said alleyway for the passage of vehicular traffic, when such alleyway is not presently improved for such purposes, nor has the city deemed it fit for such use in its present condition.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Ctiy Council of the City of LeRoy, Illinois, in lawful meeting assembled as follows:

- Section 1. The alley running East and West located in Block 70 of Conkling's Addition to the City of LeRoy, McLean County, Illinois, is hereby declared closed to vehicular traffic until further action shall properly be taken by the City of LeRoy to improve said alley and make it fit for vehicular traffic.
- Section 2. The Mayor of the City of LeRoy is hereby directed to take all necessary steps and precautions to see that appropriate notices as to the closing of the aforesaid alley to vehicular traffic are properly posted at both ends of the alley, that appropriate barriers to vehicular traffic are erected, and that all necessary work is undertaken and completed to cause said alley to generally be incapable of being utilized for the passage of vehicular traffic.
- Section 3. The utilization of said platted alleyway for the purpose of passage by any vehicle, and the parking or standing of any vehicle thereon, shall be deemed a violation of this ordinance punishable by fine as provided for in the Municipal Code, City of LeRoy, Illinois 1975 (as amended).
- Section 4. The city council hereby finds that the needs of the public and of the city at this time do not warrant the improvement of said alley, nor the opening of it to vehicular traffic, and further finds that the current trend of traffic patterns in the area of the alley and needs of the community and of the public do not indicate that such alleyway need be open at any time in the future to vehicular traffic.
- $\underline{\sf SECTION~5}$. The provisions and sections of this ordinance shall be deemed separable and the invalidity of any portion of this ordinance shall not affect the validity of the remainder.
- SECTION 6. That this ordinance shall be in full force and effect from and after its passage and approval in pamphlet form as required by law.
