## ORDINANCE NO. 262

AN ORDINANCE APPROVING THE DONATION OF MONEY FOR CHARITABLE ACTIVITIES FOR THE BENEFIT OF THE CITY OF Leroy, ILLINOIS.

WHEREAS, the Mayor and the City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have been requested to donate funds to the LeRoy Youth Center, Inc., an Illinois not-for-profit organization, which organization is presently in the process of applying for status as a tax exempt charitable organization under the Internal Revenue Code, and

WHEREAS, the Mayor and the City Council of the City of LeRoy, Illinois, have determined that the objectives and proposed activities of said organization are intended to benefit the youth of the community, and in so doing shall be of direct benefit to all residents of the City of LeRoy, and

WHEREAS, the Mayor and the City Council of the City of LeRoy, Illinois, find that it is an appropriate objective of an Illinois municipal corporation to encourage wholesome and worthwhile activities for the youth residing within the municipality and in the area surrounding the municipality and in so doing protect the health, safety and welfare of the citizens of the community,

NOW, THEREFORE, BE IT ORDAINED by the Mayor and the City Council of the City of LeRoy, Illinois, in lawful meeting assembled as follows:

Section 1. A donation in the name of the City of LeRoy and in the amount of One Thousand, Five Hundred Dollars (\$1,500.00) is hereby approved to be given to the LeRoy Youth Center, Inc., for purposes of helping said not-for-profit and charitable organization with remodeling expenses for the premises located at 208 East Center Street, and to assist in defraying the cost of the first year's insurance premium for property damage coverage and liability coverage for the activities of said organization.

Section 2. That said organization shall be required to render an accounting of all of its receipts and income for the period ending December 31, 1986, to the City Council, thereby establishing the proper expenditure of said donated funds, and such accounting shall be required to be given to the City Clerk of the City of LeRoy, Illinois, not later than February 15, 1987.

Section 3. That this donation is not intended to and does not establish an intention by the City of LeRoy to contribute a like

amount or any other amount at any future time to said organization. although the City reserves the right to make such donation of funds at a future time if it sees fit to do so.

Section 4. That this ordinance shall be in full force and effect from and after its passage and approval in pamphlet form as required by law.
