ORDINANCE NO. 504

AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE CITY OF LE ROY, MC LEAN COUNTY, ILLINOIS (TERRITORY TO BE ANNEXED BEING LOT 23 IN BUCKLE'S GROVE SUBDIVISION, SAID SUBDIVISION BEING ADJACENT TO THE CITY OF LE ROY, MC LEAN COUNTY, ILLINOIS)

Section 4. This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.




