AN ORDINANCE AMENDING THE MUNICIPAL CODE OF THE CITY OF LEROY, ILLINOIS, 1975 (as amended), CHAPTER 21, ZONING -MAP AMENDMENT

WHEREAS, a petition for change of zoning district (from time to time hereinafter referred to as "rezoning") was received by the City of LeRoy, in regard to premises described hereinafter, said petition seeking to rezone said premises from a zoning classification of A-Agricultural, which would be assigned automatically to the premises as the initial zoning classification upon the annexation of said premises into the municipal limits of the City of LeRoy, to R-1 Single Family Residential; and

WHEREAS, a public hearing was held by the Zoning Board of Appeals of the City of LeRoy, Illinois, on November 8, 2001, at 7:30 p.m. at the City Hall, LeRoy, Illinois, in accordance with the laws of the State of Illinois and the ordinances of the City of LeRoy, McLean County, Illinois, to consider said petition, after due notice was given in accordance with all applicable laws and ordinances; and

WHEREAS, said Zoning Board of Appeals did recommend to the City Council of the City of LeRoy, Illinois, that said petition to change the zoning classification of the property described hereinafter be approved; and

WHEREAS, all things required by law and ordinance to be done in regard to the rezoninig of the hereinafter described property have been completed; and

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, find such zoning map amendment request to be in the best interests of the City and its residents,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, in lawful meeting assembled, as follows:

<u>Section 1</u>: The real estate described as follows:

That part of the following described tract of land:

All that part of the North 35 acres of the Northeast 1/4 of the Northeast 1/4 of Section 29, Township 22 North, Range 4 East of the Third Principal Meridian, lying North of that part of said tract conveyed to the State of Illinois, for the use of Public Works and Buildings, by Instrument, dated May 28, 1969, recorded September 18, 1969, as Document No. 69-6697 in McLean County, Illinois,

lying South of and adjacent to Lot 20 in Sunnyside Addition to the City of LeRoy in the Southeast 1/4 of Section 20, Township 22 North, Range 4 East of the Third Principal Meridian, and the South end of Sunnyside Court, being a street in Sunnyside Addition to the City of LeRoy and South of Lot 1 in Sunnyside Addition to the City of LeRoy, all lying West of the East line of said Lot 20 extended South and South of the South line of said Lot 20 extended West in McLean County, Illinois (PIN: [BK. 15] 30-29-200-002),

is hereby zoned R-1 Single Family Residential, and said zoning classification shall be applicable effective the date of this ordinance. The City Clerk and City Engineer are hereby directed to take all action as may be necessary to amend the official zoning map of the City of LeRoy in accordance with this ordinance.

Section 2: This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
