AN ORDINANCE AMENDING THE MUNICIPAL CODE OF THE CITY OF LE ROY, ILLINOIS, 1975 (as amended), CHAPTER 21, ZONING-MAP AMENDMENT

WHEREAS, a petition for change of zoning district (from time to time hereinafter referred to as "rezoning") was received by the City of Le Roy, in regard to premises described hereinafter, said petition seeking to rezone said premises from a zoning classification of C-2, Highway Commercial, to R-1, One & Two FamilyResidential; and

WHEREAS, a public hearing was held by the Zoning Board of Appeals of the City of LeRoy, Illinois on April 18th, at 7:06 P.M. at the City Hall, Le Roy, Illinois, in accordance with the laws of the State of Illinois and the ordinances of the City of Le Roy, McLean County, Illinois to consider said petition, after due notice was given in accordance with all applicable laws and ordinances; and
