AN ORDINANCE AMENDING CHAPTER 3, CITY ADMINISTRATION, MUNICIPAL CODE OF LEROY, ILLINOIS 1975 (AS AMENDED), BY AMENDMENT OF ORDINANCE 353, AND AMENDMENT OF SECTION 1 OF THAT ORDINANCE, AND AMENDMENT OF SECTION 3.11 OF THE AFORESAID CHAPTER 3

WHEREAS, the City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is in the best interests of the City and its residents, in administering and enforcing the ordinances of the City, that an informal procedure be provided whereby persons charged with violation of certain municipal ordinances of the City may make a payment to the City and dispose of said charge in an informal, non-criminal-type proceeding, and

WHEREAS, the City Council of the City of LeRoy has previous to this date adopted Ordinance No. 353, amending Chapter 3, City Administration, Municipal Code of LeRoy, Illinois 1975 (as amended), by adoption of Section 3.11, and

WHEREAS, the City Council of the City of LeRoy deems it necessary to further amend the aforesaid Section 3.11,

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of LeRoy, in lawful meeting assembled, as follows:

That Chapter 3, City Administration, Municipal Code Section 1. of LeRoy, Illinois 1975 (as amended), Section 3.11, is hereby amended by the addition of the following words and figures at the end of the aforesaid Section, being at the end of the list designated as "4. TRAFFIC (subsection H.)":
