AN ORDINANCE AMENDING THE MUNICIPAL CODE OF THE CITY OF LE ROY, ILLINOIS, 2003 TITLE 10, ZONING MAP AMENDMENT (School District)

WHEREAS, a petition for change of zoning district (from time to time hereinafter referred to as "rezoning") was received by the City of Le Roy, in regard to premises described hereinafter, said petition seeking to rezone said premises from the automatic zoning classification of A, Agricultural that would otherwise be assigned to said property upon its annexation, to R-1, 1 and 2 Family Residential; and

WHEREAS, a public hearing was held by the Zoning Board of Appeals of the City of Le Roy, Illinois on October 9, 2003 at 7:06 P.M. at the City Hall, Le Roy, Illinois in McLean County, Illinois to consider said petition, after due notice was given in accordance with all applicable laws and ordinance; and

WHEREAS, said Zoning Board of Appeals did recommend to the City Council of the City of Le Roy, Illinois, that said petition to rezone the property upon annexation described hereinafter be approved; and

WHEREAS, all things required by law and ordinance to be done in regard to the rezoning of the hereinafter described property have been completed; and

WHEREAS, the Mayor and City Council of the City of Le Roy, McLean County, Illinois, an Illinois municipal corporation, find such rezoning request to be in the best interests of the city and its residents,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Le Roy, Illinois is lawful meeting assembled, as follows:

(to the Annexation Ordinance for the City of Le Roy property to the City of Le Roy)

A part of the $E \frac{1}{2}$ of the $SE \frac{1}{4}$ of Section 21, Township 22 North, Range 4 East of the Third Principal Meridian, McLean County, Illinois, more particularly described as follows:

Beginning at a point on the west line of the $E^{\prime\prime}$ of the $SE^{\prime\prime}$ of Section 21 a distance of 545.98 feet north of the southwest corner of the $E^{\prime\prime}$ of the $SE^{\prime\prime}$ of said Section 21; thence N.01-26'-32''E. 402.00 feet on the west line of the $E^{\prime\prime}$ of the $SE^{\prime\prime}$ of said Section 21 to the south line of the Le Roy Unit District No. 2 Athletic Field property as described in the deed recorded June 10, 1937 in Deed Book 440 on page 135; thence S.54-59'39''E. 817.87 feet on said south line of the Le Roy Unit District No. 2 Athletic Field property to the right-of-way line of S.B.I.Route 39 (US Route 150); thence S.39-43'59''E.

22.22 feet on said right-of-way line; thence S43-32-'04''E. 6.13 feet on said right-of-way line: thence S.48-43'-22''W. 19.28 feet on said right-of-way line: thence S.01-26'-32''W. 371.05 feet on a line parallel with the west line of the $E^{1/2}$ of the $SE^{1/4}$ of said Section 21; thence N.54-59'-39''W. 823.63 feet on a line parallel with the south line of the Le Roy Unit School District No. 2 Athletic Field property line to the Point of Beginning containing 6.34 acres, more or less, with assumed bearings given for description purposes only.

All that part of the S.B.I. Route 39 (US Route 150) right-of-way lying northeasterly and adjacent to Tract I and Tract II as described above, all in the E ½ of the SE ¼ of Section 21, Township 22 North, Range 4 East of the Third Principal Meridian, McLean County, Illinois.

Said Annexation Tracts I, II, and III containing approximately 10.6 acres, more or less.

This ordinance shall be in full force and effect from and after its passage and approval as required by law.
