- <u>Section 2.</u> New Section 2.06-Committees, of Chapter 2, City Council, of the Municipal Code of LeRoy, Illinois, 1975 (as amended), is hereby adopted in words and figures as follows:
 - 2.06 COMMITTEES At the beginning of each municipal year, the mayor, with the advice and consent of the council, shall appoint the following committees:
 - 1. Sidewalks, Streets, and Alleys
 - 2. Sanitary, Water and Lights
 - 3. Parks, Buildings, and Property
 - 4. License, Ordinances, and Judiciary
 - 5. Finance and Salary.
- <u>Section 3.</u> This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
