WHEREAS, A Petition to rezone the following described real estate:

That part of Lot 13 in the subdivision of the southwest quarter of Section 16, Twp. 22N, R4E of the 3rd PM described as follows: Beginning at the Northeast corner of Staley Knolls Addition to LeRoy; thence North 125 feet on the Northerly extension of the East line of Staley Knolls Addition, thence Westerly 664.73 feet more or less on a line parallel with the North line of Staley Knolls Addition to the West line of said Lot 13 to the North line of Staley Knolls Addition thence Easterly 664.73 feet on the North line of Staley Knolls Addition to the point of the beginning, containing 1.91 acres more or less and all being situated in McLean County, Illinois;
