## ORDINANCE NO. 600

AN ORDINANCE AMENDING CHAPTER 2, COUNCIL, OF THE MUNICIPAL CODE OF THE CITY OF LEROY, ILLINOIS, 1975 (as amended), BY ADDITION OF NEW SECTION 2.08 VOTING

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that in furtherance of the goals of good government and appropriate procedures to assure good government for the City and its residents, it is in the best interests of the City and of its residents, that an ordinance regarding voting procedures should be adopted,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, in lawful meeting assembled, as follows:

<u>Section 1</u>. Chapter 2, COUNCIL, Municipal Code of the City of LeRoy, Illinois, 1975 (as amended), is hereby amended by addition of Section 2.08 in words as follow:

While it is the duty of every member of the corporate authorities (Mayor and all members of the City Council) who has an opinion on any question to express it by his or her vote, such member cannot be compelled to do so; such member may prefer to abstain from voting, and in such instance, a vote of "Present," "Abstain," or of "Pass" shall be an unexcused abstention and considered a vote on the prevailing side upon announcing the adoption or rejection of a motion on the floor. However, as a general rule, no member shall vote on any question in which he or she has a direct, personal, or pecuniary interest. In such case (the member having a direct, personal or pecuniary interest in the matter upon which a vote is to be taken), such member shall announce his or her conflict and the nature thereof at the time the issue is to be debated, and shall then announce his or her intention to abstain from the voting when a vote on the question is called for, and upon the vote being taken his or her abstention shall be excused.

<u>Section 2</u>. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as required by law.
