AN ORDINANCE ZONING LAND. NEWLY ANNEXED TO THE CITY OF LEROY, MCLEAN COUNTY, ILLINOIS, SAID LAND BEING COMMONLY KNOWN AS "PARCEL "D" AS SHOWN ON THE LAWRENCE E. MARSH ANNEXATION PLAT RECORDED AS DOC. NO. 77-18580 IN THE OFFICE OF THE RECORDER OF DEEDS OF MCLEAN COUNTY, ILLINOIS".

Whereas, the land described below has been newly annexed to the City of LeRoy and was the subject matter of an Annexation Agreement entered into between the City and the Owner thereof; and

Whereas, the said Annexation Agreement provided that the City would zone this land in accordance with that agreement, specifically 1-2, HEAVY INDUSTRIAL DISTRICT; and

Whereas, prior to the annexation of the land and the execution of the Annexation Agreement all hearings required to be held took place pursuant to State Statutes,

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of LeRoy, McLean County, Illinois, as follows:

Section 1. That the land legally described as follows: "That part of the South Half (1/2) of Section 28, Township 22 North, Range 4 East of the Third Principal Meridian, McLean County, Illinois, described as follows: Commencing at the Soutwest corner of the said Section 28; thence due North 909.12 feet; thence N 89 degrees 50' E 853.08 feet to the True Point of Beginning (said point being also the Southeast corner of Parcel shown on the Lawrence Marsh Annexation Plat recorded as Doc. No. 77-18580 in the Office of the Recorder of Deeds of McLean County, Illinois); thence N 89 degrees 50° E to the West right-of-way line of State Aid Route 22; thence Northwesterly on the said West right-of-way line to the Southeast corner of Parcel "C" as shown on the aforesaid annexation plat; thence \$ 89 degrees 50' W 2,282 feet more or less on the South line of the said Parcel "C" to the East line of the said Parcel "A"; thence due South 945.0 feet on the East line of said Parcel "A" to the <u>True Point of Beginning</u> containing 50.5 acres, more or less",

shall be zoned I-2, HEAVY INDUSTRIAL DISTRICT.

Section 2. That the City Clerk is authorized and directed to show this zoning map amendment made by this ordinance upon the official zoning map of the City.

Section 3. That this ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
