AN ORDINANCE AMENDING THE MUNICIPAL CODE, LE ROY, ILLINOIS, 1975 CHAPTER 21, ZONING - MAP AMENDMENT

WHEREAS, a petition to rezone the following described real estate:

That part of the West half of the Southeast Quarter of Section 29, Township 22 North, Range 4 East of the Third Principal Meridian lying south of the Southerly right of way of F. A. Route 119 excepting 5.335 acres previously deeded to Robert and Nancy Spratt by deed recorded as Document No. 78-14716 and also excepting 12.694 acres comprising Pleasant Valley Subdivision-Phase I as shown on the plat recorded as Document No. 81-3120, said Tract I containing in all 58.8 acres more or less and all being situated in the City of LeRoy, McLean County, Illinois.

seeks to rezone said premises, from a zoning classification of R-1, 1 & 2 Family Residential, to A-Agricultural, and
