AN ORDINANCE AMENDING THE MUNICIPAL CODE, LE ROY, ILLINOIS, 1975 CHAPTER 21, ZONING - MAP AMENDMENT

WHEREAS, a petition to rezone the following described real estate:

PARCEL I: The North 155 feet of the South 310 feet of West 160 feet of Lot 2 in the Subdivision of the S1/2 of the SW1/4 of Section 21, Township 22 North, Range 4 East of the 3rd Principal Meridian, recorded in Plat Book 2a, Page 213, in the Recorder's Office of McLean County.

PARCEL 2: The North 75 feet of the South 385 feet of the West 160 feet of Lot 2 in the SE1/4 of the SW1/4 of Section 21, Township 22 North, Range 4 East of the Third Principal Meridian, in McLean County, Illinois,

seeks to rezone said premises, from a zoning classification of A-Agricultural, to R-2, General Residential, and

WHEREAS, a public hearing was held by the Zoning Board of Appeals of the City of Le Roy, Illinois, on April 18, 1991 at 7:00 P.M. at the City Hall, Le Roy, Illinois, in accordance with the laws of the State of Illinois and the ordinances of the City of Le Roy, McLean County, Illinois, to consider said petition, and

WHEREAS, said Zoning Board of Appeals did recommend to the City Council of the City of Le Roy, Illinois, that said petition for change of zoning classification as to the above-described premises be approved, and

WHEREAS, all things required by law to be done in and about the rezoning of said property have been completed;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Le Roy, Illinois, in lawful meeting assembled, as follows:

SECTION 1. That the previously described property, is hereby Zoned R-2, General Residential.

SECTION 2. That this ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
