AN ORDINANCE AMENDING THE MUNICIPAL CODE, LE ROY, ILLINOIS, 1975 (as amended), CHAPTER 21, ZONING - MAP AMENDMENT

WHEREAS, a petition for change of zoning district (from time to time hereinafter

referred to as "rezoning") was received by the City of Le Roy, in regard to premises described hereinafter, said petition seeking to rezone said premises from a zoning classification of A-Agricultural to R1, 1 and 2 Family Residential.

WHEREAS, a public hearing was held by the Zoning Board of Appeals of the City of Le Roy, Illinois, on August 18, 1994, at 7:05 p.m., at the City Hall, Le Roy, Illinois,

in accordance with all applicable laws and ordinances, and

WHEREAS, said zoning board of appeals did recommend to the City Council of the City of Le Roy, Illinois, that said petition to rezone the property described hereinafter be approved, and

WHEREAS, all things required by law and ordinance to be done in regard to the rezoning of the hereinafter described property have been completed,

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Le Roy, Illinois, in lawful meeting assembled, as follows:

SECTION 1. The real estate described as follows:

<u>Parcel No. 1</u> That part of the S.W.1/4 of the S.W.1/4 of the N.E.1/4 of Section 21, T22N, R4E of the Third Principal Meridian lying North of the former Illinois Central Gulf right of way except the following described tract:

That part of the West half of the Northeast Quarter of Section 21, Township 22 North, Range 4 East of the Third Principal Meridian described as follows: Beginning at the Northeast corner of Block 124 of Conkling's Addition to the City of Le Roy, said

point being also on the West line of the said Northeast Quarter; thence Easterly 20.0 feet on the Easterly extension of the North line of the said Block 124; thence Southerly 289.67 feet on a line parallel with the West line of the said Northeast Quarter to the Northerly right-of-way line of the former Illinois Central Gulf Railroad; thence Westerly 20.0 feet on the said right-of-way line to the West line of the said Northeast Quarter; thence Northerly 289.72 on the West line of the said Northeast Quarter to the Point of Beginning; containing 0.133 acres, more or less, and all being situated in the City of Le Roy, McLean County, Illinois.

Said parcel No. 1 containing approximately 4.37 acres is situated in the City of Le Roy, McLean County, Illinois and is further identified as Tax Parcel NO. 30-21-256-009.

Parcel No 2 That part of the N.W.1/4 of the S.W.1/4 of the N.E.1/4 of Section 21, T.22N.,R4E of the Third Principal Meridian except any portion thereof lying within Crumbaugh 1st Addition to the City of Le Roy and also except the following described tract:

That part of the Northeast Quarter of Section 21, Township 22 North, Range 4 East of the Third Principal Meridian described as follows: Beginning at the Southwest corner of Lot 21 in the Crumbaugh 1st Addition to Le Roy; thence south 116.9 feet on the Southerly extension of the West line of the Said Lot 21 to the <u>True Point of Beginning</u>; thence continuing South 110.0 feet; thence East 150.0 feet at right angles with the preceding line; thence North 110.00 feet at right angles with the preceding line; thence West 150.00 feet to the True Point of Beginning containing 0.379 acres, more or less, and all being situated in the City of Le Roy, McLean County, Illinois.

Said parcel No. 2 containing approximately 8.25 acres is situated in the City of Le Roy, McLean County, Illinois and is further identified as Tax Parcel NO. 30-21-256-007.

SECTION 2. This ordinance shall be in full force and effect from and after its passage and approval as required by law.
