## ORDINANCE NO. 760

## AN ORDINANCE AMENDING THE MUNICIPAL CODE OF THE CITY OF LEROY, ILLINOIS, 1975 (as amended), CHAPTER 21, ZONING - MAP AMENDMENT

WHEREAS, that real estate described hereafter was annexed into the City of LeRoy by Ordinance No. 679, passed and approved July 1, 1996; and

WHEREAS, application has been made to rezone the property from A, Agricultural District, to R-1, One- and Two-Family Residential District; ; and

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is in the best interests of the City and its residents, that such request for rezoning be approved,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

Section 1. The real estate described as follows:

That part of the South 1/2 of the West 1/2 of the North East 1/4 of Section 21, Township 22 North, Range 4 East of the Third Principal Meridian, McLean County, Illinois, described as follows: All that portion of the said South 1/2 of the West 1/2 of the North East 1/4 of Section 21 lying West of the East line of the said West 1/2 of the North East 1/4 of Section 21, South of Crumbaugh's Addition to the City of LeRoy, North of the North right-of-way line of the former I.C.G. Railroad, and East of the West line of the East 1/2 of the said West 1/2 of the North East 1/4 of Section 21, in the City of LeRoy, McLean County, Illinois,

is hereby rezoned from A, Agricultural District, to R-1, One- and Two-Family Residential District.

Section 2. Any building permits previously issued for any premises located within the real estate previously described herein, even though having been approved prior to the date of this ordinance, shall not be considered invalid, and any structures constructed on any part of the previously described real estate shall be considered validly constructed in accordance with all city zoning and building codes.

Section 3. This ordinance shall be in full force and effect from and after its passage and approval as required by law.
