AN ORDINANCE APPROVING A SPECIAL PERMITTED USE IN BUILDING USE REQUIREMENTS OF THE MUNICIPAL CODE OF THE CITY OF LE ROY, ILLINOIS, 2003 TITLE 10-ZONING

WHEREAS, a petition to permit a variation for the real estate described hereinafter was received by the City of Le Roy, in regard to premises described hereinafter, said petition seeking a special permitted use to allow for approximately 500 square feet of a I-l, Light Industrial building be converted to a dwelling unit intended to be used as a living quarters including complete kitchen and bathing facilities; and

WHEREAS, a public hearing was held by the Zoning Board of Appeals of the City of Le Roy, Illinois, on September 4, 2008, at 7:00 p.m. at the City Hall, Le Roy, Illinois, in accordance with the laws of the State of Illinois and the ordinances of the City of Le Roy, McLean County, Illinois, to consider said petition, after due notice was given in accordance with all applicable laws and ordinances; and

WHEREAS, said Zoning Board of Appeals did recommend to the City Council of the City of Le Roy, Illinois, that said petition for special use to allow approximately 500 square feet of an existing 2700 square feet of a I-l, Light Industrial building be converted to a dwelling unit intended to be used as living quarters including complete kitchen and bathing facilities. Granting of the aforesaid special use is conditionally valid to the current property owner only and therefore null and void with any change in ownership, and

WHEREAS, all things required by law and ordinance to be done in regard to the variation of the zoning regulations regarding the hereinafter described property have been completed,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Le Roy, Illinois, in lawful meeting assembled, as follows:

Section 1. The real estate described as follows:

Lots 11 and 12, within Block 52, of the Conklings Addition to the City of LeRoy, McLean County, Illinois (301 W. Oak)

Is hereby granted a special use to allow approximately 500 square feet of an existing 2700 square feet of a I-l, Light Industrial building be converted to a dwelling unit including a complete kitchen and bathing facilities and intended to be used as living quarters for the owners business and family needs. Conditionally, the special use is granted to the current property ownership only and therefore null and void with any change in ownership.

This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
