AN ORDINANCE APPROVING A USE AS AN ADDITIONAL PERMITTED USE IN THE C-1 CENTRAL COMMERCIAL ZONING DISTRICT
AS TO REAL ESTATE DESCRIBED AS:
THE NORTH 97.58 FEET OF LOTS 2, 3 AND 4 IN BLOCK 16
IN THE ORIGINAL TOWN OF LE ROY, MC LEAN COUNTY, ILLINOIS,

WHEREAS, a petition for approval of an additional permitted use as to real estate described in the aforesaid petition was received by the City of LeRoy, in regard to premises described hereinafter, said petition seeking approval to allow an additional permitted use as hereinafter set forth in the C-1 Central Commercial Zoning District of the City of LeRoy as to the premises hereinafter described, and
