ORDINANCE NO. 715

AN ORDINANCE ACCEPTING AND APPROVING THE AUTHORIZATION OF AN ADDITIONAL PERMITTED USE IN THE C-2 ZONING DISTRICT OF THE CITY OF LEROY

WHEREAS, the Zoning Board of Appeals of the City of LeRoy held a regular meeting on December 5, 1996, and at such meeting held a hearing on an application for additional permitted use by Richard Baum, for property presently owned by Beverly Moss, said real estate being located at 205 W. Pine Street, LeRoy, Illinois, and described as: The South 105 feet of Lot 5 and the South 100 feet of Lot 6, except the East 5 feet thereof, all in Block 20 of the Original Town of LeRoy, McLean County, Illinois; and

WHEREAS, the Zoning Board of Appeals for the City of LeRoy did authorize an additional permitted use as requested in the application, as aforesaid, dated November 14, 1996,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, in lawful meeting assembled, as follows:

Section 1. The authorization of an additional permitted use by the Zoning Board of Appeals of the City of LeRoy for the C-2, Highway-Oriented Commercial District, in the City of LeRoy, such additional permitted use being for a paper recycling business, said recycling business, and by implication said additional permitted use, being restricted as follows:

- The property shall be utilized as a recycling facility and business in accordance with the applicant's description of intended use as appended to the application for additional permitted use, dated November 14, 1996, a copy of which is attached hereto and incorporated herein by reference;
- 2) Recycling materials kept outside a building or other structure shall be enclosed;
- 3) Noxious odors shall be kept to a minimum;
- 4) Loose material and debris shall be contained so as not to create a nuisance problem for the City or property owners;
