ORDINANCE NO.00-04-01-51

AN ORDINANCE APPROVING A VARIATION IN FRONT YARD SETBACK AND REAR YEAR SETBACK REQUIREMENTS OF THE MUNICIPAL CODE, LE ROY, ILLINOIS, 1975 (as amended) CHAPTER 21 - ZONING

WHEREAS, a petition to permit a variation for the real estate described hereinafter was received by the City of Le Roy, in regard to premises described hereinafter, said petition seeking a variance in front yard setback of 25 feet to a 16 feet setback on the Wayne Street side and for a variance in rear year setback from the required 5 feet setback to a 2 feet setback to allow for the construction of a detached garage.

WHEREAS, a public hearing was held by the Zoning Board of Appeals of the City of LeRoy, Illinois, on April 6, 2000 at 7:06 P.M. at the City Hall, Le Roy, Illinois, in accordance with the laws of the State of Illinois and the ordinances of the City of Le Roy, McLean County, Illinois, to consider said petition, after due notice was given in accordance with all applicable laws and ordinances, and

WHEREAS, said Zoning Board of Appeals did recommend to the City Council of the City of Le Roy, Illinois, that said petition for variation in front yard setback of 25 feet to setback of 16 feet on the Wayne Street side and a variance in rear yard setback from the required 5 feet to a 2 feet setback to allow for the construction of a detached garage.

WHEREAS, all things required by law and ordinance to be done in regard to the variation of the hereinafter described property have been completed,

NOW, THEREFORE BE IT ORDAINED, by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

variances in the zoning ordinance front yard setback of 25 feet, and rear yard setback of 5 feet is hereby granted to allow for the construction of a detached garage with a front year setback on Wayne Street of 16 feet and a rear yard setback of 2 feet on the previously described land; said variance being from a 25 feet front yard setback to a 16 feet front year setback, and a 5 feet rear yard setback to a 2 feet setback.
