ORDINANCE NO. 00-04-02-51

AN ORDINANCE APPROVING A VARIATION IN FRONT YARD SETBACK AND FRONT YARD FENCE HEIGHT RESTRICTION OF THE MUNICIPAL CODE, LE ROY, ILLINOIS, 1975 (as amended) CHAPTER 21 - ZONING

WHEREAS, a petition to permit a variation for the real estate described hereinafter was received by the City of Le Roy, in regard to premises described hereinafter, said petition seeking a variance in front yard setback of 25 feet to a 1 foot setback on both the Center and Barnett Street Sides to allow for the construction of a 4 foot picket fence and a variance of the fence height allowable in the front yard of 30 inches from the top of the curb to a height of 48 inches from the top of the curb to allow for the construction of a 4 foot picket fence.

WHEREAS, a public hearing was held by the Zoning Board of Appeals of the City of LeRoy, Illinois, on April 6, 2000 at 8:07 P.M. at the City Hall, Le Roy, Illinois, in accordance with the laws of the State of Illinois and the ordinances of the City of Le Roy, McLean County, Illinois, to consider said petition, after due notice was given in accordance with all applicable laws and ordinances, and

WHEREAS, said Zoning Board of Appeals did recommend to the City Council of the City of Le Roy, Illinois, that said petition for variation in front yard setback of 25 feet to setback of 1 foot on the Center and Barnett Street sides and a variance of fence height allowable in the front yard of 30 inches from the top of the curb to a height of 48 inches from the top of the curb to allow for the construction of a 4 foot picket fence.

WHEREAS, all things required by law and ordinance to be done in regard to the variation of the hereinafter described property have been completed,

NOW, THEREFORE BE IT ORDAINED, by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

SECTION 1. As to the real estate described as follows:

Lots 6 and 7, Block 132 Wood and Conklings Addition to the City of Le Roy, County of McLean, Illinois

variances in the zoning ordinance front yard setback of 25 feet, and height allowable in the front yard of 30 inches above the curb is hereby granted to allow for the construction of a 4 foot picket fence with a front yard setback on Center and Barnett Streets of 1 foot and a fence height of 48 inches on the previously described land; said variance being from a 25 feet front yard setback to a 1 foot front yard setback, and a 30 inch above curb level height restriction to allow a 48 inch fence height.

SECTION 2. This ordinance shall be in full force and effect from and after its passage and approval as required by law.
