AN ORDINANCE APPROVING A VARIATION IN FRONT YARD AND SIDE YARD SETBACKS OF THE MUNICIPAL CODE, LE ROY, ILLINOIS, 1975 (as amended) CHAPTER 21 - ZONING

WHEREAS, a petition to permit a variation for the real estate described hereinafter was received by the City of Le Roy, in regard to premises described hereinafter, said petition seeking a variance in front yard setback of 25 feet to a 18 feet front yard setback and also a side yard setback of 6 feet 6 inches in R-1 Zoning to a 4 foot 6 inch side yard setback to allow for the construction of a attached garage.

WHEREAS, a public hearing was held by the Zoning Board of Appeals of the City of LeRoy, Illinois, on October 5, 2000 at 7:00 P.M. at the City Hall, Le Roy, Illinois, in accordance with the laws of the State of Illinois and the ordinances of the City of Le Roy, McLean County, Illinois, to consider said petition, after due notice was given in accordance with all applicable laws and ordinances, and

WHEREAS, said Zoning Board of Appeals did recommend to the City Council of the City of Le Roy, Illinois, that said petition for variation in front yard setback of 25 feet to setback of 18 feet and also a variance in side yard setback of 6 feet 6 inches to a 4 feet 6 inch side yard setback in a R-1 Zoning District to allow for the construction of a attached garage.

WHEREAS, all things required by law and ordinance to be done in regard to the variation of the hereinafter described property have been completed,

NOW, THEREFORE BE IT ORDAINED, by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

SECTION 1. As to the real estate described as follows:

West 15' of Lot 2, all of Lot 3, East 7' of Lot 4, Block 140, Conklings Addition commonly known as 605 E. Pine Street City of Le Roy, County of McLean, Illinois

variances in the zoning ordinance front yard setback of 25 feet and a side yard setback of 6 feet 6 inches is hereby granted to allow for the construction of a attached garage to the existing house on the previously described land; said variance being from a 25 feet front yard setback to a 18 feet front yard setback and also a 6 feet 6 inch side yard setback to a 4 feet 6 inch side yard setback to allow construction of a attached garage.

SECTION 2. This ordinance shall be in full force and effect from and after its passage and approval as required by law.
