AN ORDINANCE APPROVING A VARIATION IN FRONT YARD SETBACKS OF THE MUNICIPAL CODE, LE ROY, ILLINOIS, 1975 (as amended) CHAPTER 21 - ZONING

WHEREAS, a petition to permit a variation for the real estate described hereinafter was received by the City of Le Roy, in regard to premises described hereinafter, said petition seeking a variance in front yard setback of the required 25 feet to a setback of 20 feet on the Chestnut Street side, and also a variance in front yard setback of the required 25 feet to a setback of 13 feet on the East Street side to allow for the construction of a commercial building

WHEREAS, a public hearing was held by the Zoning Board of Appeals of the City of LeRoy, Illinois, on December 14, 2000 at 7:04 P.M. at the City Hall, Le Roy, Illinois, in accordance with the laws of the State of Illinois and the ordinances of the City of Le Roy, McLean County, Illinois, to consider said petition, after due notice was given in accordance with all applicable laws and ordinances, and

WHEREAS, said Zoning Board of Appeals did recommend to the City Council of the City of Le Roy, Illinois, that said petition for variation in front yard setback of 25 feet to a setback of 20 feet on the Chestnut Street side and a variance in front yard setback of 25 feet to a setback of 13 feet on the East Street side to allow for the construction of a commercial building.

WHEREAS, all things required by law and ordinance to be done in regard to the variation of the hereinafter described property have been completed,

NOW, THEREFORE BE IT ORDAINED, by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

SECTION 1. As to the real estate described as follows:

Lot 3 in the S.W. ¼ of Section 21, Township 22 North, Range 4 East of the Third Principal Meridian, per plat recorded in Book 41 of Deeds, Page 247, re-recorded in Plat Book 2 Page 213, and the re-survey recorded May 17, 1889 in Plat Book 2, page 516, EXCEPT that part conveyed to the State of Illinois, for the use of the Department of Public Works and Buildings by Warranty Deed dated July 8, 1969, recorded August 28, 1969 as Document No. 69-6225, and EXCEPT the railroad right of way, all in the City of Le Roy, McLean County, Illinois. Said parcel containing 0.88 acres, more or less as determined by this survey.
