AN ORDINANCE APPROVING A VARIATION IN SIDE YARD SETBACKS OF THE MUNICIPAL CODE, LE ROY, ILLINOIS, 1975 (as amended) CHAPTER 21 - ZONING

WHEREAS, a petition to permit a variation for the real estate described hereinafter was received by the City of Le Roy, in regard to premises described hereinafter, said petition seeking a variance in side yard setback of the required 10 feet to a setback of 6 feet 7 inches to allow for the construction of an addition to an existing garage.
