AN ORDINANCE APPROVING A VARIATION IN FRONT YARD SETBACKS OF THE MUNICIPAL CODE, LE ROY, ILLINOIS, 1975 (as amended) CHAPTER 21, ZONING

WHEREAS, a petition to permit a variation for the real estate described hereinafter was received by the City of Le Roy, in regard to premises described hereinafter, said petition seeking a variance in front yard setback of the required 25 feet to a setback of 19 feet to allow for the construction of a roofed porch.
